The meeting starts at 10,00 a.m.

The items on the agenda are: the status on the implementation of the activities and the expenditures of Greek partners related to the project.

Participants at the meeting are: the Municipality of Monopoli, the Municipality of Fasano, the Municipality of Grottaglie, Apulian Public Theatre Consortium, the Municipality of Parga and the Region of Western Greece.

The <u>Project Manager</u>, Mr.Vincenzo Carrieri, communicates to the participants the reasons for which the representative from the Region of Ionian Islands could not be able to participate, due to the personal problems occurred to the responsible of the project. However, she sent a report related to the status of the implementation of the project, in which many proposals are reported in order to carry on the activities. Moreover, she focuses the attention on many difficulties that they had to face in order to the procedures of the selection. These constitute the reasons of the delay that lasts still today about the appointment of the stakeholders who are going to implement the following actions: 3.1, 3.2, 3.4 e 3.5.

Talks about the status of the implementation of the project can start.



The Italian partners involved within this action communicate that the workshops came to the end, according to the application form.

The <u>Region of Western Greece</u> explains that they started the activities related to the action and they are going to be fulfilled by the end of July 2013. The representatives from <u>Parga</u> tell that activities are underway and they are going to be fulfilled by the end of July 2013.

The region of **Western Greece** communicates that the procedures related to the agreements to be subscribed with the stakeholders were fulfilled. The appointed stakeholder is already in contact with the company appointed by the Municipality of Fasano. The two stakeholders have agreed to make their debut related to the event of narration, during the theatrical season in Greece.

The Municipality of Parga underlines the fact that the co-produced event of narration in collaboration with the Municipality of Monopoli "Life, death and miracles of Saint Nicholas the greatest" that made its debut in Monopoli, on the 25th May and that it was repeated in Fasano on the 26<sup>th</sup> and in Grottaglie on the 27<sup>th</sup> had a great success in terms of audience. Partners after a long debate in finding solutions about the lack of the selected theatrical company by the Region of Ionian Islands, who is going to co-produce the narrative event in collaboration with the company appointed by the Municipality of Grottaglie, aware of the fact that because of this obstacle, the implementation of the theatrical season, according to the project, can run the risk of failure, they finally decide to call Ms. Faye Polimenou.

Ms. Faye Polimenou communicates that on May the 29<sup>th</sup> 2013 the application forms aimed to the implementation of the co-produced narrative events must be submitted. She underlines her readiness in communicating the final outcome, in order to facilitate the company selected by the Municipality of Grottaglie in carrying on the activities related to the co-produced implementation scheduled in Corfù, without running the risk of other delays or problems. In case of the failure of these procedures, project's partners decide that they are going to start talks in order to find suitable solutions.

- Project' s partners confirm all the scheduled dates related to the Theatrical Season to be implemented in Greece according to the action *3.3.*, as follows:

- Corfù: on 14th.6.13 Babele-WGR, on 15th.6.13 Diaghilev - Anaptyksis Meletitikh, on 16th.6.13 Teatro della Fede - the company who will be selected by the Region of Ionian Islands;

- Parga: on 16th.6.13 Babele-WGR, on 17th.6.13 Diaghilev - Anaptyksis Meletitikh, on 18th.6.13 Teatro della Fede - the company who will be selected by the Region of Ionian Islands;

- Patra: on 18th.6.13 Babele-WGR, on 19th.6.13 Diaghilev - Anaptyksis Meletitikh, on 20th.6.13 Teatro della Fede - the company who will be selected by the Region of Ionian Islands.

The partners decide to include in this scheduled program also the dates related to the coproduction Grottaglie/Corfù. In case of other difficulties related to the selection whose deadline - as previously reported – is May the 29<sup>th</sup> 2013, only the Corfù/Grottaglie - coproduced event will be scheduled according to other dates.

The Greek partners, in order to finalize the activities according to the project, ask to the theatrical companies selected by the Italian partners to send them by the 28<sup>th</sup> May 2013, information and all the specific technical data needed to implement effective promotional activities.

#### Action 2.4

Related to the action 2.4. on the production of a DVD on the project, the Partners confirm that the company appointed by the TTP (Apulian Public Theatre Consortium) will film the activities within the territories of the involved partners during the theatrical season in Greece. The Greek partners confirm their willingness and their efforts aimed to send all required information on the places with an historical and artistic relevance, the peculiarities of the territories and their efforts in the organization of the interviews with the local politicians/administrators.

After debating on the status of the implementation of the activities of the project, the staff of the **Municipality of Monopoli** express their concerns about the lack of Greek partners' expenditures. It is underlined the fact that the project is going to be finalized, so that, this lack of expenditures could compromise the successful fulfillment of the whole project.

The Greek partners take the floor and focus the attention on the serious administrative problems that they have to face about the transparency and the settlement of the expenditures. In spite of this fact, they undertake to submit the report of the expenditures as much as possible by the 30<sup>th</sup> June 2013. <u>Finally, the partners agree that the next meeting is going to be held in Patra on 19<sup>th</sup> June 2013.</u>
