## **Registered Participants:**

The meeting starts at 6.30 p.m.

The External Expertise, Cinzia Lagioia communicates that representatives from the Municipality of Fasano and from the Region of Ionian Islands would not be able to take part in the meeting.

Verified the attendance of the project partners majority, the meeting is declared to be validly constituted. The meeting is going to start.

About the importance to identify the stakeholders that will manage the cultural and theatrical activities Cinzia Lagioia communicates that Municipality of Monopoli, Grottaglie and Fasano have already published the open calls for expression of interest.

Pepi Theodorou refers that by the end of September Municipality of Parga will identify the stakeholders for the implementation of cultural and theatrical activities, while Christiana Lentiou asks for some clarification in order to publish the open call of the Region of Western Greece.

After a brief debate on aspects and procedures of the open call, Christiana Lentiou confirms that their Open Call will be published soon and it will be open for 3 weeks.

Considering that within the month of September the stakeholders who will manage the cultural and theatrical activities will be identified, all the Partners agree to summon the next meeting in Parga in a period between the 29 September 2012 and the 2 of October 2012.



Pepi Theodorou approves the idea.

Lino Manosperta underlines that the meeting in Parga will be the occasion to meet:

-the operators of theatrical companies selected with the Open Calls in order to implement the theatrical co productions;

-the operators of Greek televisions to realize the Project Documentary.

With reference to this latter, Lino Manosperta illustrates shortly the importance of the involvement of "Greek televisions" in the realization of the documentary.

All the Partners approve it and undertake to invite regional Greek televisions to the meeting in Parga to discuss about this activity.

Before the closure of the meeting, Municipality of Monopoli invites all the Partners to begin the contractual activities, to spend and to report their expenses.
